#### Call to order

President **Saini** called the meeting to order at 12h40 pm

#### **Notice of meeting and Quorum**

A notice of the meeting was sent to all members via the electronic Bulletin in April, 2005. There was a quorum present of 44 members all in attendance (see list above).

#### 07.01 Accept agenda

A motion by Nozzolillo to accept agenda, seconded by Jolliffe was carried unanimously.

#### 07.02 Receive minutes from executive meetings

A motion by **Bewley**, seconded by **Geitmann** to accept the minutes of the 2004 ABM, as posted on the CSPP Web site with minor modifications was carried unanimously.

#### 07.03 Reports of Officers

#### A. President – Saini

#### Plant Canada has grown up.

It is a matter of great pride that Plant Canada — the Canadian Federation of Plant Biology Societies — has now grown to include six major organizations. This year's meeting is the first to bring all six member societies together. With over 50 sessions planned, Plant Canada 2005 is promising to be the largest gathering of Canadian plant biologists in history. As one of the two founding societies, we can be truly proud of this success. In keeping with our commitment to the health and growth of this organization, CSPP has sponsored a major symposium on "Nutrient Use Efficiency" on June 15. Another highlight of the CSPP's presence at this meeting will be the Gold Medal Address by the Emeritus Professor Ragai Ibrahim on June 16.

#### New membership category and executive position.

A new 'Corporate Member' category was created at the 2004 Annual Business Meeting of the society. Recruitment for this membership category was delayed because of logistical reasons, but we are now poised for this, along with a general membership drive. As I explained earlier in a letter to the CSPP members, the creation of this membership category was intended to encourage bridge-building between the research in the university/government laboratories and corporate sector engaged in the commercialization of the results of such research. The initial target is to enroll about 10 Canadian companies active in plant biology research.

In addition, a new position of a Student/PostDoctoral Representative was added to the CSPP

executive with a view to encouraging greater involvement of these important membership categories in the affairs of the society. Andrew McCartney, a Ph.D. student at the University of Guelph, was elected to this position in April.

#### CJB name change.

At the request of the Co-Editors (Drs. Larry Peterson and Barry Shelp) of the Canadian Journal of Botany, I polled the CSPP members in November 2004 about their opinions on changing the name of the CJB. Of the 49 responses I received, 44 expressed strong support for changing the name, 3 expressed lukewarm support and 2 were against the change. Thirteen of the supportive respondents also wrote (unsolicited comment) that they would like to see the word "Canadian" dropped from the name. The following alternative names were suggested:

Plant Journal Canada Plant and Cell Biology

Plant Form and Function Plant Biology

Canadian Journal of Experimental Botany Chloros

Journal of Plant Biology Plant Biology Journal

An open meeting to further discuss this issue is scheduled on the morning of June 15 at this conference.

#### Joint meetings with the American Society of Plant Biologists in jeopardy.

The CSPP was scheduled to meet jointly with the ASPB in 2006 in Montreal, but we learned in October last year, that the ASPB had booked Boston for their 2006 meeting after rejecting a less competitive bid from Montreal. The current executive of the ASPB were apparently not aware of the commitment to meet jointly in Montreal despite an unbroken tradition of regular joint meetings dating back to 1973. We were also told that another reason the choice of Boston was that the new visa policies of the US government cause problems for foreign-born US-based researchers to get back into the country after traveling abroad. Regardless, as the joint meeting in Montreal is now impossible, we are considering alternatives, which include meeting with the ASPB in Boston or alone in Montreal.

My correspondence with the current ASPB executive leaves me with the impression that preserving the tradition of joint meetings is no longer a priority for the ASPB. Therefore, if we wish the tradition to be maintained, the incoming CSPP executive will have to pursue this issue vigorously with the ASPB.

#### Dr. Marilyn Griffith.

For the second time during my mandate, the CSPP executive suffered a tragic loss when Dr. Marilyn Griffith, the Senior Director, died on February 19, 2005 of complications arising from a stroke. With Marilyn's death, Canadian plant biology lost one of its leading practitioners and many who knew her lost a warm and ever-cheerful friend.

#### Thanks to the executive.

As I pass on the CSPP Presidency to Dr. Robert Guy, I wish to thank all my colleagues on the

executive for their strong support, cooperation and hard work over the last two years. As I leave this office, I realize that I have been serving virtually continuously on the CSPP executive in various capacities since I first came aboard in 1993 as the Bulletin Editor. These experiences have indeed been among the most enjoyable in my career, and I will forever be grateful to the CSPP members for such sustained confidence.

#### B. <u>Treasurer</u>

#### **CSPP** Corporation

#### **Function of the Corporation**

CSPP/SCPV Inc. was originally established in order to facilitate lobbying efforts on behalf of science in Canada (federal government regulations forbid charities, e.g. CSPP/SCPV, to lobby). These efforts were to be carried out in conjunction with the Canadian Federation of Biological Societies (CFBS). Once established, CSPP/SCPV Inc. collected membership dues from Society members (dues had previously been collected by CSPP/SCPV), and forwarded a portion of the dues to CFBS. The remainder of the dues was transferred to CSPP/SCPV. Charitable donations to the Duff Student Travel Bursaries and/or the Oaks Scholarship Fund were also transferred to CSPP/SCPV. This system was relatively cumbersome, but was necessary in order to carry out lobbying efforts.

With the termination of the Society's association with CFBS a few years ago, the lobbying efforts of the Society have ceased. The bookkeeping system was therefore changed, such that CSPP/SCPV (i.e. the charity) collected membership dues and charitable donations. CSPP/SCPV Inc. is now relatively inactive, and does not currently play a major financial role in the Society. This change in Society bookkeeping was enacted for September 2002, in time for the collection of 2003 membership dues.

#### **Assets and Financial Activity**

Assets of CSPP/SCPV Inc. consist solely of a chequing account containing approximately \$4,200 (see Appendix A). CSPP/SCPV Inc. had minimal financial activity in fiscal 2004; details are shown in the "Statement of Operations" (Appendix A).

#### **CSPP Charity**

#### **CSPP-Sponsored Meetings**

The Society sponsored several scientific meetings in fiscal year 2005: CSPP 2004 (held at the University of Guelph in June 2004), the Western Regional Meeting (University of Saskatchewan, December 2004), Eastern Regional Meeting (Queen's University, December 2004), and the Carbon Concentrating Mechanism (CCM) satellite conference of the International Congress of Photosynthesis (Montréal, QC) in August 2004.

CSPP 2004 yielded a net profit of approximately \$18,000. The Western Regional Meeting provided a profit of approximately \$250, and the Eastern Regional Meeting a profit of approximately \$1,900. The profits from the Eastern Regional Meeting will be counted in fiscal year 2006, as the cheque arrived just a few days too late to count for fiscal 2005. The CCM meeting organizers have repaid the seed money (\$2,000) provided by CSPP; final accounting for the meeting is not yet complete.

As well, the accounting for two other CSPP-sponsored meetings, Plant Canada 2003 (held at St. Francis Xavier University) and the 2003 Eastern Regional Meeting (Concordia University) arrived in fiscal year 2005, and these meetings are thus included in that fiscal year.

#### **George Duff Student Travel Fund**

Almost \$1600 was donated by Society members to the Student Travel Fund in fiscal year 2005. A total of \$3500 was awarded in support of student travel to CSPP 2004; the difference in funding was supplied by general Society revenues.

#### Dr. Ann Oaks Scholarship Fund

A total of \$1255.00 was donated by Society members to the Oaks Scholarship Fund in fiscal year 2005. The Oaks Scholarship Fund was established by a donation from long-time CSPP/SCPV member Dr. Ann Oaks; Dr. Oaks has also made subsequent donations to the Fund. As well, CSPP/SCPV has been named as the beneficiary of a life insurance policy by Dr. Oaks; the proceeds of the policy will be added to the Oaks Scholarship Fund. The Fund will be used to support one or more PhD students in plant biology at a level comparable to an NSERC PGS Doctoral scholarship. The Fund is currently accumulating monies (with permission from the Canada Revenue Agency), and operation of the Fund is overseen by a Board of Trustees.

#### **Big Picture of the Society's Finances**

The Society includes both CSPP/SCPV Inc. and the CSPP/SCPV. As well, both Society entities have several different bank accounts and investments, and money is sometimes transferred between entities and between accounts. Therefore, it can be difficult to understand the financial status of the Society as a whole when looking only at individual entities.

In order to understand the overall Society finances, I have combined CSPP/SCPV Inc. and the CSPP/SCPV into one analysis, and also removed the Oaks Fund from the analysis. The rationale for removing the Oaks Fund is that it is presently an accumulative fund, and is not part of the operating revenue of the Society (unlike the Duff Travel Fund, which both collects and awards money). The "big picture" is summarised in Appendix B.

#### **CSPP/SCPV** Membership

Annual membership trends are shown in an attached table in Appendix C.

#### Auditing

#### C. Communication Director

The Communications Director chairs the Communications Committee which consists of a chair, the CSPP secretary and the Website Coordinator.

#### Website

The "new" Society web site was unveiled in early June 2004 and has been up for just over a year now. I feel it has achieved its goal of improving overall user 'friendliness'. I encourage the membership to visit and browse the site as well as use the services provided such as Job Postings and Meeting Announcements. These services have proved to be effect in at least reaching the membership and I have had several e-mails commenting on this aspect of the site. However, like most web sites it is a "work-in-progress". There is still room from improvement and the comments of the membership are always appreciated. In my estimation, the next hurdle will be designing a "Members Only" area which can be used for membership renewals, membership directory information and the sharing of teaching resources.

#### Membership Directory

The goal of disseminating a 2004 Membership Directory has come and gone. I take responsibility for this delay and will attempt a 2005 Membership Directory to be targeted for mailing in the late summer. This will be up to date as of the Annual Meeting and include any amendments to the bylaws and constitution, as well as "late" membership renewals.

#### Meeting Program/Abstract Booklets

Last year I had indicated the Society still required copies of abstract booklets from three meetings. These have been received and we know have a complete compilation of abstract booklets from all meetings since 2000. These will now be sent out to our distribution list. **Meeting Organizers** - **Please remember to send a few copies (electronic or hard copy) to the Communications Director so we can keep this up to date.** 

The BULLETIN was published in October and May respectively and posted on the website

The website was well maintained with a significant increase in activity observed over the course of the year. I would like to extend my thanks to the members of the Communications Committee for all of their hard work. It is greatly appreciated.

#### D. Eastern Regional Director

#### Site for the 2005 Eastern Regional Meeting

At this point, I have been unable to secure a site for the 2005 meeting and time is obviously running short. I have been working on this since January but without any luck. I have tried individuals at York, McMaster, Western, UTSC, Carleton, Ottawa. I am still waiting for a response from Ottawa.

#### **2004 Eastern Regional Meeting**

The 2004 Eastern Regional Meeting was held at the Biosciences Complex on the campus of Queen's University, Kingston Canada. Events began with a Friday night mixer in the Atrium and continued with poster and oral sessions throughout a full Saturday schedule. The oral sessions began with two plenary talks. The first was by Maria Harrison (Cornell University), describing her work on arbuscular mycorrhiza. The second was delivered by Normand Brisson (University of Montreal) and

described his work on defense gene regulation by transcription factors. Both talks were excellent and well received.

In keeping with tradition, the meeting included graduate student awards for best oral and best poster presentations. Numerous faculty were involved in the judging of presentations and a choice of winners was made difficult by the all-round excellence of the candidates. Best oral presentation was awarded to Dominic Rosso (University of Western Ontario), for his talk on the *Arabidopsis* IMMUTANS. Best poster presentation was awarded to Jeff Waller (Queen's University) for his poster on NADH kinases. Honorable mentions went to Martha Mullally (Carleton University; oral) and Mark Held (University of Waterloo; poster).

The CSPP thanks **Wayne Snedden** and **Lynn O'Malley** (Queen's University) for organizing this very successful meeting!

#### Potential Sites for the 2006 and 2007 Eastern Regional Meetings

McMaster University (Elizabeth Weretilnyk, Robin Cameron) have expressed some interest to host the 2006 meeting. I will try to confirm this site in late 2005. Univ. of Western Ontario (Mark Bernards) has expressed some interest to host the 2007 meeting, so that it could coincide with the opening of their new Biotron.

#### George H. Duff Student Travel Bursary

In coordination with the Western Regional Director (Doug Muench), travel bursaries were awarded to all 34 applicants who asked for assistance to attend Plant Canada 2005, Edmonton.

Given the large number of applicants, 6,000 dollars in bursary monies were awarded. Award amounts were based solely on travel distance. The table below indicates the province by province allocation:

#### E. Western Regional Director

#### **Report on the Western Regional Meeting**

The 2004 CSPP Western Regional Meeting was held December 9-10 at the University of Saskatchewan. Over 50 plant biologists representing each of the western provinces attended. The

meeting was highlighted by excellent talks from the invited speakers, Federica Brandizzi (Life inside a plant cell: dynamics of the early secretory pathway) and Lacey Samuels (Building a cell wall: new models for wax and monolignol export). The opening mixer amidst the dinosaurs in the Biology/Geology atrium, and the closing banquet at Marquis Hall, provided the participants with the opportunity to discuss science in a relaxed atmosphere.

The Western Regional Director Awards were presented for best oral and poster presentations, and included an award certificate and cash prize. Jaqueline Hulm (supervisor – Peta Bonham-Smith) was awarded the best oral presentation for her talk entitled "The four members of the ribosomal protein S15A gene family are differentially transcribed in *Arabidopsis thaliana*." The top poster award went to W.P. Liu (supervisor – John King) for her presentation entitled "One carbon (C-1) metabolism in response to biotic and abiotic stresses."

The meeting was organized by Gordon Gray (University of Saskatchewan) and Douglas Muench (University of Calgary).

#### **Future site of the Western Regional Meeting**

Discussions have been initiated to determine the site of the next Western meeting, which we would like to hold in either 2005 or 2006. We hope discussions that take place at the Plant Canada meeting in Edmonton will result in a tentative date and location for the meeting.

#### F. Meeting Sites

There was little for the Meeting Site Committee to do this year, due to the excellent work of the previous committee and, because of Plant Canada, meeting sites are more-or-less out of our hands every second year. The following table indicates existing plans for upcoming annual meetings:

At the Annual General Meeting in Guelph, June 2004, a "Plant Science Teaching Network" was initiated. An important tool of this network was supposed to be an online database that lists courses related to plant science that are given by CSPP members. The feedback by the members was very positive and thanks to Michael Stasiak the data have been entered onto a web page that is accessible through the Education page of the CSPP web site (http://cspp-scpv.ca/education/edu-teaching.shtml). A total of 24 courses is listed so far. Information on textbooks and practicals as well as course web sites are available for all of these courses. Furthermore, contact information is provided to allow direct communication with the course instructors. This should facilitate communication and thus allows new faculty members or those who plan to set up a new course or modify an existing one to be inspired by the exchange with colleagues.

New additions or corrections to the database are welcome. It will be updated as needed.

#### **Teaching session - Plant Canada 2005**

Together with Christine Maxwell (Canadian Botanical Association) I am organizing a session dedicated to plant science related education entitled "**Teaching in plant sciences**" (sessions D8 and E7). The session will take place during the Plant Canada meeting on Thursday, June 16. We were able to recruit the following speakers: David Cass, John Hoddinott, Frédérique Guinel and Elizabeth Straszynski.

#### **Round table discussion - Plant Canada 2005**

Together with Randy Currah (University of Alberta), Heather Addy (University of Calgary) and Christine Maxwell (Trent University) I am organizing a roundtable discussion with the following (hopefully controversial) title: "Does the modern biology student need botany?" The roundtable is scheduled for an hour on June 16, during the Plant Canada meeting (following session E7). The following panelists will participate: Marie Davey, Hugues Massicotte, Cindy Graham, Frédérique Guinel and Peta Bonham-Smith. Initial opening statements and panelist discussion will be followed by a discussion including the audience.

#### H. Science Policy

NSERC was contacted about the reallocation process and we were told that it was under discussion and they would get back to us later. I really don't have any issues to bring forward.

Any suggestions related to science policy are welcome but no other issues needed our attention this year. **Saini** mentioned that Plant Canada would create a Science Policy sub committee made of science policy directors of constituent societies.

#### I. Student/postdoc representative

The position of Student/Postdoctoral Officer was created at the last Annual General Meeting held in Guelph, ON, in June 2004. The position was filled in April 2005 following a call for nominations. The mandate of the Student/Postdoctoral Officer is to represent the interests of student and postdoctoral members and to highlight the contributions of these members within the Society.

To begin to fulfill the duties of this position, a request was made to the student/postdoctoral membership to provide ideas on the specific issues they would like addressed by the Officer. The following is a list of most preferred topics arising from those consultations:

#### **Employment:**

It was suggested that a website be created to list positions available in the plant sciences. Most individuals were not aware that the CSPP already provides such a list on its website. An announcement regarding this resource would be beneficial.

#### **Career Development:**

Advice on topics dealing with career development is desirable, including writing CVs, manuscripts and grants, and job applications and interviews.

#### **Women in Science:**

An informal discussion dealing with issues pertaining to women in science was organized at the CSPP Eastern Regional Meeting in 2002. The symposium was well received by those in attendance and, therefore, it was suggested that a similar event be attempted at the national level.

A motion by **Peterson**, seconded by **Sheoran** to accept the report of CSPP officer as presented was carried unanimously.
